

CARTA'S STUDENT BYE PASS APPLICATION for Middle & High School Students (Grades 6-12)

CARTA has a reduced fare program for middle and high school students. Upon presentation of the CARTA Student Bye Pass card, students who are in grades 6-12 are entitled to ride CARTA buses for one-half of the regular adult cash fare or for 75¢. The reduced fare is offered during all hours of operation.

Eligible students must complete the information on the attached application **AND** the student's enrollment must be verified by a representative at the attending school. The representative must be the school secretary, guidance counselor, administrator, or authorized personnel. Applications without the verification of school enrollment or incomplete information on the application will be denied.

The Student Bye Pass card is a photo identification card that is issued in person at the CARTA office located at 1617 Wilcox Boulevard, or at the Chattanooga Parking Authority located at 1362 Market Street next to the Chattanooga Choo Choo, Monday through Friday between 8:00 a.m. and 5:00 p.m.

The cost for the Student Bye Pass card is \$2.00 and it is valid for one school year and through the summer before the next school year begins. Replacement cards will cost \$5.00. Upon expiration, a new application must be submitted and a new card issued for \$2.00.
