No vaccine is 100% effective. Some who get it are still at risk. 3. Vaccines don't provide immediate protection. Immunity occurs two weeks after the second shot. 4. Epidemiologists know the vaccine keeps you from getting ill, but don't know yet if it also keeps you from transmitting it to others. 5. Masks protect people with compromised immune systems and other at-risk conditions; the vaccine may not work for them (cancer patients, or those who cannot get the shots due to allergies to something in the vaccine. "The best hope for ending the pandemic isn't to choose between masks, physical distancing and vaccines, but to combine them. "The three approaches work best as a team."
